#### **CALL TO ORDER**

The Canvassing Board meeting was called to order by Judge Daniel J. Kanner at 9:00 a.m.

Motion to begin the Logic and Accuracy Test was granted by the present Canvassing Board members. Kevron Aird provided an overview of the Logic and Accuracy Test process.

Equipment being tested today: (16) Election Day DS200 machines, (4) Early Voting DS200 machines, and (10) Vote-by-Mail high speed scanners (DS850s).

A predetermined script was provided to the Canvassing Board members. Zero reports from DS850 high-speed scanners and DS200 machines were presented to the Canvassing Board members for review. Permission to start feeding test ballots into the machines was granted by the Canvassing Board members.

The Canvassing Board members reviewed and signed the total numbers obtained from the DS200 machines and totals from the DS850s high speed scanners. Kevron Aird requested permission to clear the machines. Motion to zero out all machines was granted by the Canvassing Board members.

Motion to authorize the opening and processing of the Vote-by-Mail ballots was approved by the Canvassing Board members.

Public Inspection will take place from 8:30 a.m. to 9:00 a.m. daily. Motion to approve Guideline & Procedures Regarding the Canvassing Board Meetings Including Public Participation was granted by the Canvassing Board members.

Motion to approve the results of the Logic & Accuracy Test was granted by the Canvassing Board members.

Motion to authorize the tabulation of Vote-by-Mail ballots and duplication of ballots was granted by the Canvassing Board members.

Zero report from DS850s and zero tapes from the DS200s were reviewed by the Canvassing Board members. Motion that all machines were zero out was granted by the Canvassing Board members. Motion to shut down and seal election machines was granted by the Canvassing Board members.

All materials from the Logic and Accuracy Test are stored in two bins with seal #s 0205922, 0205923, 0205924 and 0205925.
